

# GUJARAT UNIVERSITY

## THREE YEARS' LL.B. SEM. –I ON LINE ADMISSION NOTICE YEAR –2023-24

1. On Line Applications are invited for Centralized Admission Process of LL.B. Semester I for all law colleges affiliated with the Gujarat University offering LL.B. (Three Years' Programme) programme by the Gujarat University through its website <https://oas2023.guadmissions.in/> from **13-06-2023**. **The students seeking admission at above programme have to make on line registration. The detailed flow chart showing process to make on line application is uploaded on the above link. The schedule and tentative dates for on line admission process of Three Years' LL.B. Programme will be placed by notice on the above mentioned website from time to time.**
2. All the students who are graduates from any discipline from recognized universities having 45 % or equivalent grade for General and EWS category, 42 % or equivalent grade for SEBC Candidates and 40 % or equivalent grade for SC and ST candidates are eligible to apply by on-line admission process.
3. Students have to apply for quick registration by logging on to the website of the Gujarat University <https://oas2023.guadmissions.in/> of Three Years' LL.B. programme by giving their mobile number and e mail id from **13-06-2023**. **After process of quick registration the student will be given User Name and Password on given Mobile by SMS and also on given e mail id. Thereafter, the student has to make on line payment of Rs. 175/- being registration charges for on line admission process. Students are instructed to preserve the above User Name and password for making inquiry about Admission related information and merit.**
4. After Quick Registration students have to undergo the process of filling particulars, academic details and to upload their Passport size photograph, signature, marksheets, School Leaving Certificate and other documents like caste certificate, Non Creamy layer Certi, EWS Certi, Phy. Hand Certificate etc. (whichever is applicable). **The students who have passed their qualifying Examination (Graduation- only B.Com., B.A. or B.Sc.) from the Gujarat University in April/May 2023 at the first trial have to merely enter their University Seat Number and name of Examination. The software will automatically display the name and marks of the students. If the software does not display the marks, then only the student has to enter marks manually.** The student has to then press button of LOCK after verification of his/her particulars. Thereafter, the student will be able to download the application form. In case of some deficit in filling up on line form, the student will be informed by SMS and e mail to rectify the error/defect within 24 hours by logging on his/her user ID and password.

5. The students have to read carefully the instructions from the Booklet (soft copy is uploaded on the website of the Gujarat University) and accordingly apply on line by logging on the website of the University <https://oas2023guadmissions.in/>
6. Before initiating On-line Application Process, student must have legible and clear soft copy (in jpeg format or pdf format not exceeding 300 kb size) of :
- Passport Size Photograph
  - soft copy of student's signature
  - Soft copy of Mark-sheets of last 4 semesters (or last two years as the case may be) of Qualifying Examination (B.Com., B.A., B.B.A., B.E. etc) are to be attached.
  - Soft copy of Category Certificate, issued by the Competent authority of the Government of Gujarat if applicable (SC/ST/EWS/SEBC/Phy. Handi.)
  - Soft copy of Non-Creamy Layer Certificate issued by the Competent Authority of State of Gujarat for SEBC Category candidate
  - Soft Copy of School Leaving Certificate or any other proof of Date of Birth
  - **Equivalence Percentage Certificate** issued by the Competent Authority of respective University, if the mark-sheet of last two semesters reflects grades only and does not show percentage or total marks. **PLEASE ATTACH EQUIVALENT PERCENTAGE CERTIFICATE ONLY OF THE MARKS OBTAINED IN LAST TWO SEMESTERS OF QUALIFYING EXAMINATION IF STUDENT HAS ONLY GRADE MARKSHEETS AND MARKS/PERCENTAGES OF THAT SEMESTER IS NOT WRITTEN.**  
**Please attach equivalent percentage certificates showing separately the percentages of marks of last year and second last year of qualifying examinations obtained by the students.**  
(In order to prepare Merit List, it is mandatory to upload Equivalence Percentage Certificate, if no marks or percentages are mentioned in the mark-sheets of the candidate. **If mark-sheet shows only grade or CGPA of the candidate and candidate has not uploaded Equivalence Percentage Certificate of Qualifying Examination issued by the competent authority of the concerned University, the candidate shall not be included in the merit list.**)
  - Soft copy of **Provisional Eligible Certificate (PEC)**, to be obtained from the Gujarat University by making on line application to be obtained through following link (only for candidates who have passed their last exam from **any University outside Gujarat State.**)
7. **Students from other University situated outside the State of Gujarat are required to obtain on line Provisional Eligibility Certificate from the Gujarat University website before making on-line application for LL.B. Semester – I Admission.**

However, the students belonging to University other than Gujarat University, situated within the State of Gujarat are required to obtain the On Line Provisional Eligibility Certificate (PEC) only after they are offered and allotted admission in any of the Law Colleges.

The students who have passed Qualifying Examination i.e. Graduation Examination from the Gujarat University and completed other programme from other University are considered within the category of the students of the Gujarat University, but are required to obtain Provisional Eligibility Certificate(PEC) as above mentioned process. The Students who have passed Graduation Examination from other University and thereafter taken admission at any course/programme of the Gujarat University will be considered within the category of "Other University". However, such candidates need not have to apply for the Provisional Eligibility Certificate.

8. While applying for on-line registration, the students have to fill the particulars of their Graduation (Last four semesters' Marks or last two years' Marks), HSC Exam Marks, Date of Birth as well as other particulars in prescribed column. Student has to upload his/her passport size photograph and his/her signature. Students whose mark-sheet contains grade have to calculate equivalent percentages of last two semesters and get the same verified at specified Help Centre.

9. If the students have not uploaded soft copies of Category Certificates (SC/ST/SEBC) or Non-Creamy Layer Certificates or EWS Category or Physically Handicapped Category Certificates (as the case may be) issued by the Competent Authority of the State of Gujarat showing 40% or more disability even after intimation through message within 24 hours after message, then their registration shall be considered in General Category.

Candidate has to select minimum seven colleges as per his/her preference while filling on line form.

**10. Students pursuing CA, CS or any other full time professional or other course are not permitted to simultaneously pursue LL.B. Programme as per the Bar Council of India Rules. Three Years LL.B. Programme is a Full time Programme wherein 70% attendance in each semester is compulsory as per BCI Rules and Gujarat University Ordinances.**

**11. Provisional Merit List will be prepared from all eligible candidates who have online applied for Three Years' LL.B. Programme by the Admission Committee. The students have to confirm their name and merit number by entering their User Id, Password and Captcha Code by logging on to Gujarat University Website on the date of publication of Provisional Merit List. No admission can be offered from the Provisional Merit List. In case of any discrepancy/error in the merit, category etc. the candidate has to make online application for the correction along with soft copy of necessary Supportive Documents, Mobile Number of candidate and their Registration Number on following e mail Id within the period specified in the notice of Provisional Merit List :**

**No correction shall be entertained after the specified period.**

**12. There will be online publication of Final Merit List at the website of the Gujarat University on the listed date or thereafter. The students can view their position and offered college by entering their Registration Number, Pin Number and serial number.**

**13. The students will be offered admission depending upon their merit, category and availability of seats.**

**14. The students who are offered admission can only take out print of Admission Offer Letter. The students whose name is listed in Final Merit List have to take out print of the admission offer letter and also make online payment of such amount as prescribed towards the part payment of fees (Rs. 500/- for male and Rs. 200/- for female – Part Payment of fees) and report himself/herself at the college where admission is offered and pay the remaining fees as well as present all relevant original documents for verification of the college within the prescribed days failing which he/she shall not claim admission at the offered college. Before making online payment of Ad-hoc fees of Rs. 500/- for male student and Rs.200/- for female student, the candidate has to give the correct particulars about the Bank Account. In the event of refund of amount of Ad hoc fees, the same will directly be credited in the aforesaid Bank account after completion of entire admission process.**

**15. Candidates whose names are not found in the First Merit List may wait for the second Merit List.**

**16. If a candidate wants to wait for the reshuffling round and does not want to secure admission at the first allotted Centre of Legal Education, then he/she must make online payment of only ad hoc fees of (Rs. 500/- for male and Rs. 200 for female candidate) and opt for reshuffling. (Here candidate need not have to pay any fees at that college offered to him/her at the first round, if he/she doesn't want to take admission in the said institution and wait for reshuffling round).**

**17. If any candidate is not offered any Centre of Legal Education at the First Round, may wait till the declaration of the reshuffling round.**

18. At the reshuffling option, it shall be permissible for the candidate to change his/her preferences of Centre of Legal Education given earlier. Based upon the Candidate's merit, caste, choice, and availability of seats he/she may be offered another Centre of Legal Education wherein he/she has to secure admission within the stipulated time with all necessary original documents and by paying the entire remaining amount of fees, failing which his/her offered admission at the reshuffling round shall automatically stand cancelled.
19. On publication of the Second Merit, the candidates who are offered seats have to undergo the same process of admission as described hereinabove for Round 1.
20. For any additional inquiry student may contact nearest law college Help Centres or get telephonic information during working hours of the colleges.
21. **The candidates having 30 or more years and Candidates of SC and ST category having more 35 or more years on 15-06-2023 shall be granted conditional admission as per the Interim Order of the Supreme Court of India. Such candidates have to file an undertaking to the effect that their admission shall be subject to final decision of the Supreme Court of India and shall have to present the same to the college where he/she is offered admission. The specimen format of verification is also attached at Page 27 in the soft copy of Information Booklet uploaded on the website of the Gujarat University.**
22. **As Three Years' LL.B. Programme is a professional Programme, the structure of the programme will depend upon the circulars and instructions published by the Bar Council of India time to time. At present this programme is divided into six semesters. However, the Bar Council of India may change the structure of this programme pursuant to New Education Policy 2020. In such circumstances, this programme structure may be changed by the Gujarat University and the colleges affiliated with it. Such changes, if done shall be binding to the students admitted in any law college affiliated with the Gujarat University.**
