## GUJARAT UNIVERSITY INTEGRATED LAW ADMISSION PROGRAMME Procedure for Reshuffling:

- If the candidate has not secured admission at the offered Centre of Legal Education in Round 1, and waited for re-shuffling round or not offered admission in Round 1, he/she may participate at Reshuffling Round through link <a href="https://oas2023.guadmissions.in">https://oas2023.guadmissions.in</a> and by giving user Id and password. Then give on line consent for the participation at the Re-shuffling Round with or without changing preferences of colleges.
- It shall also be permissible to participate for any candidate at the on line Reshuffling Round even without on-line payment of Ad-hoc fees of Rs.5000/-.
- If a candidate has already secured admission by payment of the entire fees at the college after having offered admission at any Centre of Legal Education (Law College) in the first round, it shall not be permissible for him/her to participate at the reshuffling round.
- After having offered admission at the First Round of allotment, if a candidate does not secure admission nor give on line consent for the reshuffling, then he/she shall not have any claim/right over the first offered Centre of Legal Education on the basis of Final Merit List/First Allotment Offer. Such candidate will be out of Centralized Admission Process.
- The candidates who are not offered admission in the first round may wait for the second round. Such candidates may exercise reshuffling option only if they are desirous to change college preference of colleges. Based upon the availability of seats and their merit, such candidates may be offered admission in the second allotment.

# Date for exercising on line Reshuffling option : 29<sup>th</sup> June 2023 till 5.00 pm

No admission / reporting shall be entertained by the Centre of Legal Education in the First Round of Allotment through Centralized Admission Process after the above dates and the candidate who fails to complete above mentioned process shall be included within the list of 'Non-reported Candidates'.

## **Reshuffling Process:**

#### Who can apply for Reshuffling?

- Those students who are allotted Center of Legal Education in the First Allotment Offer but do not want to take admission at the allotted Center of Legal Education (College) and wait for the upgradation.
- Those students who are not allotted Center of Legal Education in the First Allotment Offer and want to change their earlier preference of colleges- Center of Legal Education.

#### Who cannot apply for Reshuffling?

Those students who have already secured admission at the First Allotment by payment of entire fees at allotted Center of Legal Education are not permitted to apply for Reshuffling.

#### How to apply for Reshuffling?

### Who can opt for Reshuffling:

- Candidate is offered admission in the First Allotment Offer, and pays Ad-hoc fees of Rs.5000/- and does not take admission at allotted college in Round 1 by payment of entire fees.
- Candidate who is offered admission in First Round but has not paid Ad-hoc Fees of Rs. 5000/-
- candidate who is not offered admission in Round 1
